- Citizenship: Applicants must be Pakistani citizens with a CNIC or NICOP and must be at least 18 years old by August 31, 2024.
- Free Registration Form: The registration form is free and can be obtained at Humara Ghar offices or downloaded from the Humara Ghar website at www.humaraghar.com.pk. The form cannot be sold by any individual or organization.
- Payment: The registration fee should be deposited at any branch of Bank Alfalah Ltd or United Bank Ltd. Payments can also be made via Bank Draft, Pay Order, or online transfer to Humara Ghar Private Limited. Please ensure to include the original deposit slip or proof of payment with your registration form when submitting it at the designated Humara Ghar offices authorized by NPF.
- Single Plot Registration: Each registration form is valid for the purchase of one residential plot only.
- Benefit for Police Personnel: Police personnel can receive a non-refundable benefit of Rs. 50,000 by National Police Foundation by presenting a police service/employment card. This benefit applies to one card only.
